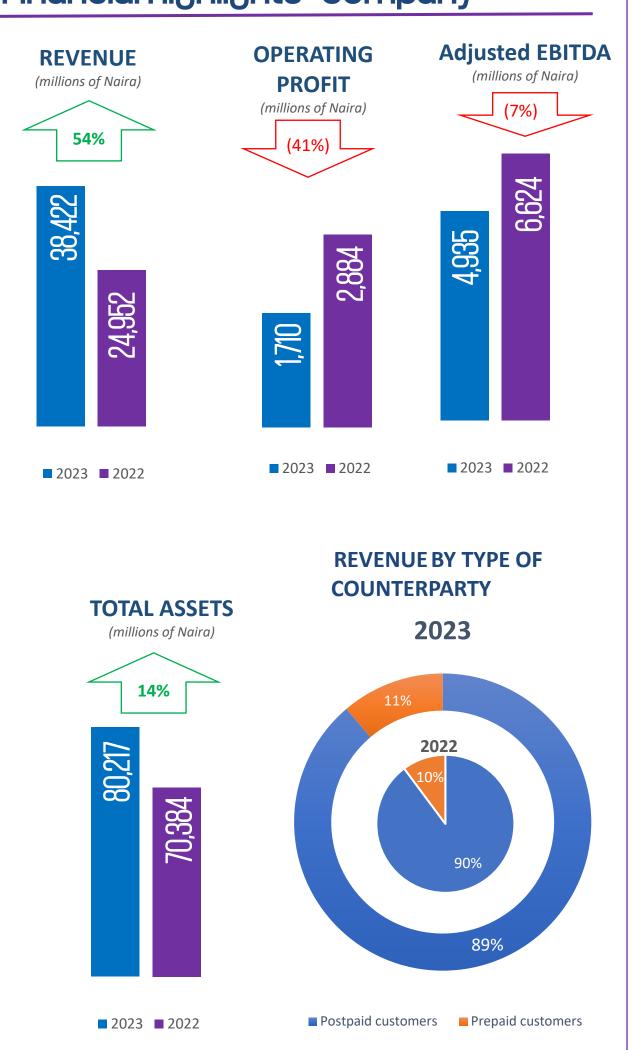

Directors' Report

For the year ended 31 December 2023

The directors present their report on the affairs of Yola Electricity Distribution Plc ("the Company"), together with the financial statements and auditor's report for the year ended 31 December 2023.

Legal form and background of the Company

Yola Electricity Distribution Plc ("the Company" or "YEDC") was incorporated in Nigeria on 07 November 2005 as a public liability company to take over electricity distribution activities and related business of the Power Holding Company of Nigeria ("PHCN") within Adamawa, Borno, Taraba and Yobe states.

As part of the Federal Government of Nigeria's ("FGN's") initiative to transform the power sector, the Nigerian Electricity Regulatory Commission (NERC) was established in October 2005 as required under the Electric Power Sector Reform Act (EPSRA) 2005. NERC is Nigeria's independent regulatory agency for the Nigerian electricity industry comprising generation, transmission and distribution sectors and regulates the activities of the Company.

In 2013, the FGN completed its planned privatisation of the electricity sector effectively handing over 5 generation and 11 distribution companies to new owners under various share sale agreements. As a result of this, 60% equity interest in the Company was acquired by Integrated Energy Distribution and Marketing Company, ("IEDMC"). After two years of operating the Company, IEDMC declared a force majeure and the Company was handed over to FGN in 2015 under the control of the Bureau of Public Enterprises ("BPE"). From 2015 to 2021, the Company was under the control of BPE until it was reprivatized in 2022.

On 01 January 2022, Quest Electricity Nigeria Limited ("QENL") acquired 60% equity interest in the Company following the execution of a Performance Agreement, a Share-Sale and Purchase Agreement, and a Shareholders Agreement between BPE, the Company, and QENL. As a result of the acquisition by QENL, a newly constitued Board and Management took over the reins of the Company.

Principal Activity

The principal activity of the Company is the distribution of electricity to its customers within its licensed franchise areas.

^{*}On 15 January 2024, the Ministry of Finance Incorporated (MOFI) formally terminated the Power of Attorney (PoA) granted to the Bureau of Public Enterprises (BPE) in the 11 Electricity Distribution Companies (Discos), directing that henceforth, equity interests of the Federal Government of Nigeria (FGN) in all electricity successor companies be held by MOFI. This new structure is yet to be implemented as at the date of issue of these financial statements.

Corporate Governance

Subsequent to QENL's acquisition of 60% equity interest in the Company, and consistent with applicable NERC rules, the Board re-emphasized the maintenance of high standards of corporate governance, central to achieving the Company's objective of maximizing shareholder value. As a result, the Board has a schedule of matters reserved specifically for its decision and the Directors have been empowered by the provision of access to learning appropriate professional skills and knowledge development.

NERC rules require that the Company has at least five directors of which at least one must be an independent director. The Company has eight (8) directors comprising seven (7) non-executive directors and one (1) executive director. The Company does not have an independent director.

Material Agreements

The Company has entered into the following material agreements:

1. Deeds of assignment of pre-handover receivables and liabilities

The Company signed a deed of assignment of pre-handover receivables and liabilities with the Nigerian Electricity Liability Management Company Limited (NELMCO) effective 01 January 2022. As part of the privatisation initiative and the restructuring of the Nigerian power sector, NELMCO was established to take over and manage the stranded assets and liabilities in the power sector.

a. Pre-handover receivables

Per the deed of assignment of pre-handover receivables, all the trade receivables of the Company as at 01 January 2022 were transferred to NELMCO without recourse. Further interpretation accorded to the definition of pre-handover receivables by NERC expanded this to include cash and cash equivalents held as at 01 January 2022. See Note 11.

b. Pre-handover liabilities

Per the deed of assignment of pre-handover liabilities, all liabilities and contingent liabilities of the Company as at 01 January 2022 were transferred to NELMCO subject to certain terms and conditions, which the Board believes do not limit the transfers. On the basis of the agreements above, management derecognised qualifying assets and liabilities as at 01 January 2022 from the 2022 financial statements. See Note 11.

2. Technical Agreement with Related Party

The Company has an operations, management and maintenance contract with Societe Nigerienne D'Electricite for the provision of local, top level and expatriate staff to enable the Company meet the performance standard in the Performance Agreement entered into with BPE (Note 29(b)(iii)).

Geographical presence

To enable the Company operate within its licensed area where it distributes electricity, it has eighteen (18) (2022: sixteen (16)) districts, excluding the head office, across Adamawa, Borno, Taraba and Yobe states. Each business unit is headed by a business manager who reports to the leadership team based at the head office.

Property, plant and equipment

Information relating to changes in property plant and equipment is disclosed in Note 14 to these financial statements.

Charitable donations

In accordance with Section 43 (2) of the Companies and Allied Matters Act, CAMA, 2020, the Company did not make any donation or gift to any political party, political association or for any political purpose in the course of the year (2022; Nil).

Employment and employees

c) Employment of physically challenged persons

The Company has three (3) physically challenged persons in its employment (2022: Nil). In the event of members of staff becoming physically challenged, every effort is made to ensure that their employment with the Company continues and that appropriate training is arranged. INDEPENDENT AUDITOR'S REPORT

To the Shareholders of Yola Electricity Distribution Plc

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Yola Electricity Distribution Plc (the Company), which comprise:

- the statement of financial position as at 31 December 2023;
- the statement of profit or loss and other comprehensive income;
- the statement of changes in equity;
- the statement of cash flows for the year then ended; and
- the notes, comprising material accounting policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Company as at 31 December 2023, and of its financial performance and its cash flows for the year then ended in accordance with IFRS Accounting Standards as issued by the International Accounting Standards Board (IFRS Accounting Standards) and in the manner required by the Companies and Allied Matters Act (CAMA), 2020 and the Financial Reporting Council of Nigeria (Amendment) Act, 2023.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Company in accordance with International Ethics Standards Board for Accountants *International Code of Ethics for Professional Accountants (including International Independence Standards) (IESBA Code)* together with the ethical requirements that are relevant to our audit of the financial statements in Nigeria and we have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code.  Furthermore, tariffs are regulated and the multi year tariff order (MYTO) is issued during the year to update for changes in macroeconomic conditions.

The Company's process of implementing the changes is manual and prone to error.

How the matter was addressed in the audit

Our audit procedures in this area included the following:

- We obtained an understanding of the Company's customer billing and meter reading processes and evaluated the design and implementation of the relevant controls in relation to revenue estimation and billing systems.
- For revenue recognised in respect of unmetered customers, we evaluated the reasonableness of the assumptions underlying the Company's estimated billing methodology by recomputing energy billed to test that the total energy billed is not higher than total energy received.
- We evaluated the multi year tariff order issued with respect to metering and billing of customers and assessed how the Company had complied with the orders in formulating its billing and revenue recognition methodology by recomputing revenue based on the order.
- We evaluated the adequacy of the financial statements disclosures including disclosures of key assumptions and judgements.

Impairment of trade receivables

See Note 4(R) and 30(B)(a) to the financial statements for the Company's accounting policy on impairment of receivables and related disclosures.

The key audit matter

As at 31 December 2023, the Company reported an impairment allowance of № 23.10 bilion against the gross trade receivables balance of № 34.52 billion. The allowance for expected credit loss represents 66% of the gross trade receivable balance.

The impairment allowance on trade receivables has remained significant as recovery of amounts billed to post-paid customers continues to be a challenge.

We considered this a key audit matter due to the materiality of the amounts involved and the high level of judgement required in determining the key inputs for the expected credit loss model used in calculating impairment allowance.

How the matter was addressed in the audit

Our audit procedures in this area included the following:

- obtaining an understanding of the Company's process and control over measurement of Expected Credit Loss model on trade receivables.
- evaluating the ECL modelling techniques and methodology used by the Company in comparison to the requirements of the relevant accounting standards.
- challenging key assumptions applied in the impairment of financial assets by comparing the assumptions to our expectations based on knowledge of the Company, industry, relevant market parameters and other externally derived data.





- assessing the categorization of the Company's receivables for the purpose of ensuring that outstanding receivables are correctly classified based on their credit risk characteristics and their identified settlement patterns.
- evaluating completeness of the disclosures made by management in the financial statements against the disclosure requirements of the relevant IFRS Accounting Standards.

Information Other than the Financial Statements and Audit Report thereon

The Directors are responsible for the other information. The other information comprises the Corporate Information, Financial Highlights, Directors' Report, Statement of Directors' Responsibilities, Statement of Corporate Responsibility, Report of the Audit and Risk Committee and Other National Disclosures, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of the Directors for the Financial Statements

The Directors are responsible for the preparation of financial statements that give a true and fair view in accordance with IFRS Accounting Standards and in the manner required by the Companies and Allied Matters Act (CAMA), 2020 and the Financial Reporting Council of Nigeria (Amendment) Act, 2023, and for such internal control as the directors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Company or to cease operations, or have no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

Identify and assess the risks of material misstatement of the financial statements, whether due to
fraud or error, design and perform audit procedures responsive to those risks, and obtain audit
evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting
a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may
involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.





- Obtain an understanding of internal control relevant to the audit in order to design audit procedures
 that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the
 effectiveness of the Company's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the directors.
- Conclude on the appropriateness of directors' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the Audit and Risk Committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

From the matters communicated with the Audit and Risk Committee, we determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

1.1 Reporting entity

Yola Electricity Distribution Plc ("the Company"), was incorporated on November 7, 2005 as a Limited Liability Company to take over as a going concern, the electricity distribution activities and related business of the Power Holding Company of Nigeria ("PHCN") within the franchise area of its network which comprised of four (4) states namely Adamawa, Borno, Taraba and Yobe states. The Company is domiciled in Nigeria and has its registered office address at 2, Atiku Abubakar Road, Jimeta, Yola, Adamawa State.

The Company was in the distribution sector of the PHCN which was a state-owned Electric Power Company. However, it was sold to Integrated Energy Distribution and Marketing Company, ("IEDMC"), in 2013 as part of the privatization of the electric power sector. The sale was authorized by the Bureau of Public Enterprises ("BPE"). Effective from 1 November 2013 (referred to as the handover date), the Federal Government of Nigeria (FGN) handed over the Company and other unbundled assets to their new owners. After two years of operating the Company, IEDMC declared a force majeure and the Company was handed over to FGN in 2015 and was under the control of BPE.

Quest Electricity Nigeria Limited ("QENL") acquired 60% equity interest in the Company following the execution of a Performance Agreement, a Share-Sale and Purchase Agreement, and a Shareholders Agreement between BPE, the Company, and QENL on 01 January 2022.

The Company is primarily involved in the distribution of electricity. This includes activities such as billing, metering and maintenance of its network assets and all other related services within its franchise network.

1.2 Basis of accounting

These financial statements have been prepared in accordance with IFRS Accounting Standards as issued by the International Accounting Standards Board (IFRS Accounting Standards), and in the manner required by the Companies and Allied Matters Act (CAMA), 2020 and the Financial Reporting Council of Nigeria (Amendment) Act, 2023.

The financial statements were authorised for issue by the Board of Directors on31 October ... 2024.

Details of the Company's accounting policies, including changes thereto, are included in Note 5.

1.3 Basis of measurement

The financial statements have been prepared in a historical cost basis except for plant and machinery class within property, plant and equipment which has been recognized on a revaluation model basis.

1.4 Functional and presentation currency

These financial statements cover the financial year from 1 January 2023 to 31 December 2023, with comparative figures for the financial year from 1 January 2022 to 31 December 2022.

This set of financial statements have been presented in Nigerian Naira ("NGN"), which is the Company's functional currency. All amounts stated in NGN have been rounded to the nearest thousand, unless otherwise stated.

2 Going concern

The Company reported a loss after tax of NGN 1.16 billion for the year ended 31 December 2023, as at the same date, it's current liabilities exceeded its current assets by NGN 10.61 billion (2022: NGN 3.62 billion).

Mainstream Energy Solutions Limited, its ultimate parent company, has confirmed its willingness to provide financial support to the Company in order to enable it to operate as a going concern and to meet its obligations for a period of twelve (12) months from the date of issue of these financial statements.

Based on the foregoing, the directors of the Company have a reasonable expectation that the Company will continue in operational existence for the foreseeable future and as such, be able to realize its assets and discharge its liabilities in the normal course of business. Accordingly, these financial statements have been prepared on the basis of accounting policies applicable to a going concern.

3 Changes in material accounting policies

A Material accounting policy information

The Company also adopted *Disclosure of Accounting Policies (Amendments to IAS 1 and IFRS Practice Statement 2)* from 1 January 2023. Althought the amendments did not result in any changes to the accounting policies themselves.

The amendments require the disclosure of 'material', rather than 'significant', accounting policies. The amendments also provide guidance on the application of materiality to disclosure of accounting policies, assisting entities to provide useful, entity-specific accounting policy information that users need to understand other information in the financial statements.

Management reviewed the accounting policies and made updates to the information disclosed in Note 5 Material accounting policies (2022: Significant accounting policies) in certain instances in line with the amendments.

4 New and revised IFRS Accounting Standards in issue but not yet effective

A number of new Standards, Amendments to Standards, and Interpretations are effective for annual periods beginning after 1 January 2024 and have not been applied in preparing these financial statements. 5 Material accounting policies

The Company has consistently applied the following accounting policies to all periods presented in these financial statements, unless otherwise stated.

A Revenue from contract with customers

The company is in the business of distribution of electricity. Revenue from contracts with customers is recognized when control of the goods or services are transferred to the customer at an amount that reflects the consideration to which the Company expects to be entitled in exchange for those goods or services. The performance obligation of the Company is satisfied overtime as electricity is supplied to the customers. Therefore, revenue is recognized to the extent that it is probable that the economic benefits will flow to the company and can be reliably measured.

Revenue is measured at fair value of the consideration received/receivable, excluding Value Added Tax (VAT). Revenue from the sale of electricity to post-paid and prepaid customers is the value of the volume of energy units supplied and consumed by the customers or upon completion of services rendered in line with the applicable tariff framework. Prices charged by the Company for electricity distribution are regulated through Multi Year Tariff Order (MYTO).

Revenue from the sales of electricity to post-paid customers is the value of the volume of units supplied during the year.

In the case of prepaid customers, revenue is recognised based on the estimation of energy consumed as at year end, while unutilized energy is regarded as unearned revenue and it is included in the financial statement as contract liability.

The Company does not recognise an asset or liability, as the case may be, on account of under recovery or over recovery except where it is obligated to provide future services at a loss in which case a provision is recognized.evenue is measured based on the consideration specified in a contract with a customer. The Company recognises revenue when it transfers control over a good or service to a customer.

The following table provides information about the nature and timing of the satisfaction of performance obligations in contracts with customers, including payment terms, and the related revenue recognition policies.

The Company assesses whether the transferred item meets the definition of an asset, and if so recognizes the transferred asset as PPE. At initial recognition, its cost is measured at fair value, and a corresponding amount is recognized as revenue when the Company has no future obligations, otherwise as contract liabilities.

B Property, plant and equipment

i Recognition and measurement

The cost of an item of property, plant and equipment is recognized as an asset if it is probable that future economic benefits associated with the item will flow to the company and the cost can be reliably measured. Spare parts, stand-by equipment and servicing equipment are recognised as property, plant and equipment if they are expected to be used for more than one period, otherwise, such items are classified as inventories.

Distribution network assets

The Company's distribution network assets are stated at fair value using the revaluation model less accumulated depreciation and accumulated impairment losses and is generally depreciated over the estimated useful life of the assets. Operating assets includes the core assets which the Company uses in carrying out its normal course of business; distributing power to high network and other customers. They include the overhead lines and cables, underground cables, plant and machinery (transformers, feeder pillars), meters, towers and substation buildings.

Revaluations are performed by independent professional valuers with sufficient regularity to ensure that the carrying amount is not materially different from the fair value. Generally this is carried out once in five years unless required earlier to meet any external covenant to ensure that the carrying amount of these assets does not differ materially from that which would be determined using the fair values at the end of the reporting period.

Any increase in value, on revaluation, is recognized in other comprehensive income and presented in the revaluation reserve in equity unless it offsets a previous decrease in value recognized in profit or loss in respect of the same asset. A decrease in value is recognized in profit or loss to the extent it exceeds an increase previously recognized in other comprehensive income in respect of the same asset.

The revaluation surplus within the revaluation reserve is realised upon disposal of a revalued asset.

Assets under construction are stated at cost which includes cost of material and direct labour and any costs incurred in bringing it to its present location and condition.

Non-distribution network assets

The Company's non distribution assets are measured at cost, less accumulated depreciation and any accumulated impairment losses. Depreciation is on a straight line method over the estimated useful lives of the assets. Non-operating assets includes land, administrative office building, furniture and fittings, motor vehicles, etc. Land is not depreciated.

In line with IAS 16, subsequent expenditure is included in the asset's carrying amount or recognised as a separate asset only if it is probable that the future economic benefits associated with the expenditure will flow to the Company. The carrying amount of the replaced component is derecognized.

• Contribution of assets by customer

Contributions by customers of items of property, plant and equipment (PPE), which require an obligation to supply goods to the customer in the future, are recognized at the fair value when the Company has control of the item. The Company assesses whether the transferred item meets the definition of an asset, and if so recognizes the transferred asset as PPE. At initial recognition, its cost is measured at fair value, and a corresponding amount is recognized as income when the Company has no future performance obligations. If the Company is yet to discharge the future performance obligation, the corresponding amount is recognized as a deferred income pending the performance of the obligation. This is then released to profit or loss as revenue as the performance obligation is discharged overtime.

ii Subsequent expenditure

The cost of replacing part of an item of property, plant and equipment is recognized in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its costs can be measured reliably. The carrying amount of the replaced part is derecognized. The cost of day to day servicing of property, plant and equipment is recognized in the statement of profit or loss and other comprehensive income as incurred.

iii Depreciation

Depreciation of an asset commences when the asset is available for use i.e. when it is in the location and condition necessary for it to be capable of operating in a manner intended

Depreciation is recognized in the statement of profit or loss and other comprehensive income on a straightline basis over the estimated useful life of each part of an item of equipment. The depreciation rates applied for the year are as follows:

Depreciation methods, useful lives and residual values are reviewed at each reporting date and adjusted if appropriate. No depreciation is charged on assets under construction. The attributable cost of each item of asset under construction is transferred to the relevant category of property, plant and equipment when they become ready for use and is depreciated accordingly. Depreciation of an asset ceases at the earlier of the date that the asset is classified as held for sale in accordance with IFRS 5 and the date that the asset is derecognized.

iv Derecognition

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gains and losses arising on the disposal or retirement of an item of property, plant and equipment is determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and is recognized net within the statement of profit or loss and other comprehensive income.

C Intangible assets

Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortisation and accumulated impairment losses. Acquired computer software licences are capitalized on the basis of costs incurred to acquire and bring the specific software to the useful state.

Subsequent expenditure

Subsequent expenditure is capitalized only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure, including expenditure on internally generated goodwill and brands, is recognised in profit or loss as incurred.

Amortisation

Amortisation is calculated to write off the cost of intangible assets less their estimated residual values using the straight-line method over their estimated useful lives, and is generally recognised in profit or loss.

The estimated useful lives for current and comparative periods are as follows:

Amortisation methods, useful lives and residual values are reviewed at each reporting date and adjusted if appropriate.

Derecognition

An intangible asset is derecognized on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognized in profit or loss when the asset is derecognized.

D Financial instruments

i Recognition and initial measurement

Trade receivables are initially recognised when they are originated. All other financial assets and financial liabilities are initially recognised when the Company becomes a party to the contractual provisions of the instrument.

A financial asset (unless it is a trade receivable without a significant financing component) or financial liability is initially measured at fair value plus, for an item not at FVTPL, transaction costs that are directly attributable to its acquisition or issue. A trade receivable without a significant financing component is initially measured at the transaction price.

ii Classification and subsequent measurement

Financial assets

On initial recognition, a financial asset is classified as measured at: amortised cost; FVOCI – debt investment; FVOCI – equity investment; or FVTPL. Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets, in which case all affected financial assets are reclassified on the first day of the first reporting period following the change in the business model. A financial asset is measured at amortised cost if it meets both of the following conditions and is not designated as at fair value through profit or loss (FVTPL):

- it is held within a business model whose objective is to hold assets to collect contractual cash flows; and
- its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

All financial assets not classified as measured at amortised cost are measured at FVTPL. On initial recognition, the Company may irrevocably designate a financial asset that otherwise meets the requirements to be measured at amortised cost as at FVTPL if doing so eliminates or significantly reduces an accounting mismatch that would otherwise arise.

Financial assets: Business model assessment

The Company makes an assessment of the objective of the business model in which a financial asset is held at a portfolio level because this best reflects the way the business is managed and information is provided to management. The information considered includes:

- the stated policies and objectives for the portfolio and the operation of these policies in practice. These
 include whether management's strategy focuses on earning contractual interest income, maintaining a
 particular interest rate profile, matching the duration of the financial assets to the duration of any related
 liabilities or expected cash flows or realising cash flows through the sale of the assets;
- how the performance of the portfolio is evaluated and reported to the Company's management;
- the risks that affect the performance of the business model (and the financial assets held within that business model) and how those risks are managed;
- how managers of the business are compensated e.g. whether compensation is based on the fair value of the assets managed or the contractual cash flows collected; and
- the frequency, volume and timing of sales of financial assets in prior periods, the reasons for such sales and expectations about future sales activity.

Transfers of financial assets to third parties in transactions that do not qualify for derecognition are not considered sales for this purpose, consistent with the Company's recognition of the assets. Financial assets that are held for trading or are managed and whose performance is evaluated on a fair value basis are measured at FVTPL.

Financial assets: Assessment whether contractual cash flows are solely payments of principal and interest

For the purpose of this assessment, "principal" is defined as the fair value of the financial asset on initial recognition. "Interest" is defined as consideration for the time value of money and for the credit risk associated with the principal amount outstanding during a particular period of time and for other basic lending risks and costs (e.g. liquidity risk and administrative costs), as well as a profit margin.

In assessing whether the contractual cash flows are solely payments of principal and interest, the Company considers the contractual terms of the instrument. This includes assessing whether the financial asset contains a contractual term that could change the timing or amount of contractual cash flows such that it would not meet this condition. In making this assessment, the Company considers:

- contingent events that would change the amount or timing of the cash flows;
- terms that may adjust the contractual coupon rate, including variable-rate features;
- prepayment and extension features; and
- terms that limit the Company's claim to cash flows from specified assets.

A prepayment feature is consistent with the solely payments of principal and interest criterion if the prepayment amount substantially represents unpaid amounts of principal and interest on the principal amount outstanding, which may include reasonable additional compensation for early termination of the contract.

Financial assets - Subsequent measurement and gains and losses

Financial assets at fair value through profit or loss (FVTPL): These assets are subsequently measured at fair value. Net gains and losses, including any interest income, are recognised in profit or loss.

Financial assets at amortised cost

These assets are subsequently measured at amortised cost using the effective interest method. The amortised cost is reduced by impairment losses. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain or loss on derecognised in profit or loss.

Financial liabilities: Classification, subsequent measurement and gains and losses

Financial liabilities are classified as measured at amortised cost or FVTPL. A financial liability is classified as FVTPL if it is classified as held for trading or it is designated as such on initial recognition. Financial liabilities at FVTPL are measured at fair value and net gains and losses, including any interest expense, are recognised in profit or loss. The financial liabilities are subsequently measured at amortised cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognised in profit or loss. Any gain or loss on derecognition is also recognised in profit or loss.

iii Derecognition

Financial assets

The Company derecognises a financial asset when the contractual right to the cash flows from the financial asset expires, or it transfers the right to receive the contractual cash flows in a transaction in which substantially all of the risks and rewards of ownership of the financial asset are transferred or in which the Company neither transfers nor retains substantially all of the risks and rewards of ownership and it does not retain control of the financial asset.

The Company enters into transactions whereby it transfers assets recognised in its statement of financial position, but retains either all or substantially all of the risks and rewards of the transferred assets. In these cases, the transferred assets are not derecognised.

Financial liabilities

The Company derecognises a financial liability when its contractual obligations are discharged or cancelled, or expire. The Company also derecognises a financial liability when its terms are modified and the cash flows of the modified liability are substantially different, in which case a new financial liability based on the modified terms is recognised at fair value. On derecognition of a financial liability, the difference between the carrying amount extinguished and the consideration paid (including any non-cash assets transferred or liabilities assumed) is recognised in profit or loss.

iv Offsetting

Financial assets and liabilities are offset and the net amount presented in the statement of financial position when, and only when, the Company has a legally enforceable right to set off the amounts and intends to either settle them on a net basis or to realise the asset and settle the liability simultaneously.

E Equity-accounted investee

i Interest in equity-accounted investee

The Company's interests in equity-accounted investee comprise interests in a joint venture.

A joint venture is an arrangement in which the Company has joint control, whereby the Company has rights to the net assets of the arrangement, rather than rights to its assets and obligations for its liabilities.

Interests in the joint venture are accounted for under the equity method. They are initially recognized at cost, which includes transaction costs. Subsequent to initial recognition, the financial statements include the Company's share of the profit of loss and OCI of equity-accounted investee, until the date on which significant influence or joint control ceases.

ii Equity method

Under the equity method of accounting, the investments are initially recognized at cost and subsequently adjusted for the Company's share of the associate's profits or losses and other comprehensive income. The Company's share of profits or losses and other comprehensive income of the joint venture is recognized in the statement of comprehensive income. The Company reassesses its joint control over the joint venture on an ongoing basis. Dividends received or receivable from the joint venture are recognised as a reduction in the carrying amount of the investment.

Where the Company's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, the Company does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the Company and the joint venture are eliminated to the extent of the Company's interest in this entity. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred.

Upon loss of joint control over the joint venture, the Company measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the joint venture upon loss of joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

F Income tax

Income tax expense comprises:

- current tax (Company Income tax, Tertiary Education tax, Nigeria Police Trust Fund levy); and
- deferred tax.

It is recognised in profit or loss except to the extent that it relates to a business combination, or items recognised directly in equity or in other comprehensive income.

The Company has determined that interest and penalties relating to income taxes, including uncertain tax treatments, do not meet the definition of income taxes, and therefore are accounted for under IAS 37 *Provisions, Contingent Liabilities and Contingent Assets*.

i Current tax

Current tax comprises the expected tax payable or receivable on the taxable income or loss for the year, and any adjustment to tax payable or receivable in respect of previous years. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects uncertainty related to income taxes, if any. It is measured using tax rates enacted or substantively enacted at the reporting date and is assessed as follows:

- Company income tax is computed on taxable profits
- Tertiary education tax is computed on assessable profits
- Nigeria Police Trust Fund levy is computed on net profit (i.e. profit after deducting all expenses and taxes from revenue earned by the company during the year).

Total amount of tax payable under CITA is determined based on the higher of two components namely Company Income Tax (based on taxable income (or loss) for the year); and minimum tax. Taxes based on profit for the period are treated as income tax in line with IAS 12.

Current tax assets and liabilities are offset if certain criteria are met. The Company offsets the tax assets arising from withholding tax (WHT) credits and current tax liabilities if, and only if, the entity has a legally enforceable right to set off the recognised amounts, and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously. The tax asset is reviewed at each reporting date and written down to the extent that it is no longer probable that future economic benefit would be realised.

ii Minimum tax

Minimum tax which is based on a gross amount is outside the scope of IAS 12 and therefore, are not presented as part of income tax expense in the profit or loss. Minimum tax is determined at a base rate of 0.5% of the qualifying company's gross turnover less franked investment income. The Finance Act defines

gross turnover as the gross inflow of economic benefits (cash, revenues, receivables and other assets) arising from the operating activities of a Company, including sales of goods, supply of services, receipt of interest, rents, royalties or dividends.

Where the minimum tax charge is higher than the Company Income Tax (CIT), a hybrid tax situation exists. In this situation, the CIT is recognised in the income tax expense line in the profit or loss and the excess amount is presented above the income tax line as minimum tax.

iii Deferred tax

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Deferred tax is not recognised for:

- temporary differences on the initial recognition of assets or liabilities in a transaction that
 - i. is not a business combination; and
 - ii. at the time of the transaction (i) affects neither accounting nor taxable profit or loss and (ii) does not give rise to equal taxable and deductible temporary differences;
- temporary differences related to investments in subsidiaries, associates and joint arrangements to the
 extent that the Company is able to control the timing of the reversal of the temporary differences and it is
 probable that they will not reverse in the foreseeable future; and
- taxable temporary differences arising on the initial recognition of goodwill.

Deferred tax assets are recognised for unused tax losses, unused tax credits and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which they can be used. Future taxable profits are determined based on the reversal of relevant taxable temporary differences.

If the amount of taxable temporary differences is insufficient to recognise a deferred tax asset in full, then future taxable profits, adjusted for reversals of existing temporary differences, are considered, based on the business plans of the Company. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realised; such reductions are reversed when the probability of future taxable profits improve.

Unrecognised deferred tax assets are reassessed at each reporting date and recognised to the extent that it has become probable that future taxable profits will be available against which they can be used.

Deferred tax is measured at the tax rates that are expected to be applied to temporary differences when they reverse, using tax rates enacted or substantively enacted at the reporting date, and reflects uncertainty related to income taxes, if any.

The measurement of deferred tax reflects the tax consequences that would follow from the manner in which the Company expects, at the reporting date, to recover or settle the carrying amount of its assets and liabilities. Deferred tax assets and liabilities are recorded under non-current assets and liabilities and are offset at single entity level if related to offsettable taxes. The balance of the offset, if positive, is recognised under 'Deferred tax assets' and, if negative, under 'Deferred tax liabilities'. When the results of transactions are recognised directly in shareholders' equity, current taxes, deferred tax assets and liabilities are also charged to shareholders' equity.

Deferred tax assets and liabilities are offset only if certain criteria are met.

G Foreign currency transactions

Transactions in foreign currencies are translated into the Company's functional currency at the exchange rates at the dates of the transactions.

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the prevailing exchange rate at the reporting date. Non-monetary assets and liabilities that are measured at fair value in a foreign currency are translated into the functional currency at the exchange rate when the fair value was determined.

Non-monetary items that are measured based on historical cost in a foreign currency are translated at the exchange rate at the date of the transaction.

Foreign currency differences are generally recognised in profit or loss and presented within finance income and costs.

H Cash and cash equivalents

In the statement of financial position, cash and bank balances comprise cash (i.e. cash on hand and demand deposits) and cash equivalents. Cash equivalents are short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather for investment or other purposes.

Bank balances for which use by the Company is subject to third party contractual restrictions are included as part of cash unless the restrictions result in a bank balance no longer meeting the definition of cash.

Contractual restrictions affecting use of bank balances are disclosed in note 20. If the contractual restrictions to use the cash extend beyond 12 months after the end of the reporting period, the related amounts are classified as non-current in the statement of financial position.

For the purposes of the statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts which are repayable on demand and form an integral part of the Company's cash management. Such overdrafts are presented as short-term borrowings in the statement of financial position.

I Statement of cash flows

The statement of cash flows is prepared using the indirect method. Changes in statement of financial position items that have not resulted in cash flows such as other non-cash items, have been eliminated for the purpose of preparing the statement. Dividends paid to ordinary shareholders are included in financing activities. Interest paid, other than borrowing cost on qualifying assets, is also included in financing activities while interest income is included in investing activities.

Borrowing costs paid that are directly attributable to the acquisition, construction or production of a qualifying asset are included in investing activities.

J Employee benefits

i Short-term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

ii Defined contribution plans

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Obligations for contributions to defined contribution pension plans are expensed as an employee benefit expense in profit or loss in the periods during which services are rendered by employees.

As required by the Pension Reform Act 2014, the Company has instituted a defined benefit contribution pension scheme for its staff. The employees' contributions to the scheme are funded through payroll deductions while the Company's contributions are accrued and charged fully to the profit or loss. Employees contribute 8% of their gross emoluments on a monthly basis while the Company's monthly contribution is 10% of gross emoluments.

iii Medical insurance scheme

The Company subscribes to a medical insurance plan on behalf of its employees, paying a gross premium to a health management organization based on the level of the employee.

iv Termination benefits

Termination benefits are payable when employment is terminated by the Company before the normal retirement date, or whenever an employee accepts voluntary redundancy in exchange for these benefits. The Company recognises termination benefits at the earlier of the following dates: (a) when the Company can no longer withdraw the offer of those benefits; and (b) when the entity recognises costs for a restructuring that is within the scope of IAS 37 and involves the payment of termination benefits.

In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to their present value

K Finance income and finance costs

Finance income comprises interest income on cash and cash equivalents, short-term investments and foreign currency gain on financial assets and liabilities.

Finance costs comprise interest expense on interest-bearing borrowings, lease liabilities and foreign exchange loss on financial assets and liabilities. Borrowing costs are recognised using effective interest rate and those not directly attributable to the acquisition, construction, or production of a qualifying asset are recognized in profit or loss.

Foreign currency gains and losses on financial assets and financial liabilities are reported on a net basis as either finance income or finance cost depending on whether foreign currency movements are in a net gain or net loss position.

L Inventories

Inventories are stated at the lower of cost and net realizable value. Inventories represent spare parts and other consumables, the majority of which is consumed by the Company's projects in provision of its services within one financial year. Cost comprises; direct materials and, where applicable, direct labour costs and those overheads that have been incurred in bringing the inventories to their present location and condition.

Cost is determined by the Weighted Average Cost method.

Net realizable value represents the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

M Leases

At inception of a contract, the Company assesses whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

i As a lessee

At commencement or on modification of a contract that contains a lease component, the Company allocates the consideration in the contract to each lease component on the basis of its relative stand-alone prices. However, for the leases of property the Company has elected not to separate non-lease components and account for the lease and non-lease components as a single lease component.

The Company recognises a right-of-use asset and a lease liability at the lease commencement date.

The right-of use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received. It is subsequently measured at cost less accumulated depreciation and impairment losses.

The right-of-use asset is subsequently depreciated using the straight-line method from the commencement date to the end of the lease term, unless the lease transfers ownership of the underlying asset to the Company by the end of the lease term or the cost of the right-of-use asset reflects that the Company will exercise a purchase option. In that case the right-of-use asset will be depreciated over the useful life of the underlying asset, which is determined on the same basis as those of property and equipment. In addition, the right-of-use asset is periodically reduced by impairment losses, if any, and adjusted for certain remeasurements of the lease liability.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate.

The Company determines its incremental borrowing rate by obtaining interest rates from various external financing sources and makes certain adjustments to reflect the terms of the lease and type of the asset

leased.

Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments, including in-substance fixed payments;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable under a residual value guarantee;
- the exercise price under a purchase option that the Company is reasonably certain to exercise, lease payments in an optional renewal period if the Company is reasonably certain to exercise an extension option; and
- penalties for early termination of a lease unless the Company is reasonably certain not to terminate early.

The lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability (using the effective interest method) and by reducing the carrying amount to reflect the lease payments made. It is remeasured:

- when there is a change in future lease payments arising from a change in an index or rate;
- if there is a change in the Company's estimate of the amount expected to be payable under a residual value guarantee; and
- if the Company changes its assessment of whether it will exercise a purchase, extension or termination option or if there is a revised in substance fixed lease payment.

When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

From 1 January 2021, where the basis for determining future lease payments changed as required by interest rate benchmark reform, the Company remeasures the lease liability by discounting the revised lease payments using the revised discount rate that reflects the change to an alternative benchmark interest rate.

The Company presents right-of-use assets that do not meet the definition of investment property and lease liabilities as separate lines in the statement of financial position.

Short-term leases and leases of low-value assets

The Company has elected not to recognise right-of-use assets and lease liabilities for leases of low-value assets and short-term leases. The Company recognises the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

N Provisions and contingent liabilities

Provisions

A provision is recognized if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material) using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Contingent liabilities

A contingent liability is a possible obligation that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company, or a present obligation that arises from past events but is not recognized because it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation; or the amount of the obligation cannot be measured with sufficient reliability.

Contingent liabilities normally comprise of legal claims under arbitration or court process in respect of which a liability is not likely to occur. Contingent liabilities are only disclosed and not recognized as liabilities in the statement of financial position.

If the likelihood of an outflow of resources is remote, the possible obligation is neither a provision nor a contingent liability and no disclosure is made.

O Operating profit

Operating profit is the result generated from the continuing principal revenue-producing activities of the Company as well as other income and expenses related to operating activities. Operating profit excludes net finance costs, minimum tax, and income taxes.

P Share capital

The Company has only one class of share, ordinary shares. Ordinary shares are classified as equity. When new shares are issued, they are recorded at their value. The excess of the issue price is recorded in the share premium reserve. Incremental costs directly attributable to the issue of ordinary shares are recognised as a deduction from equity. Income tax relating to transaction costs of an equity transaction is accounted for in accordance with IAS 12.

Q Government Intervention

Government interventions are initially recognized as deferred income at fair value if there is reasonable assurance that they will be received and the Company will comply with the conditions associated with the grant. They are then recognized in profit or loss as an other income on a systematic basis over the useful life of the associated asset.

Grants that compensate the Company for expenses incurred are recognized in profit or loss as a reduction from the related expense on a systematic basis in the periods in which the expenses are recognized.

R Impairment

i Non-derivative financial assets

Financial instruments and contract assets

The Company recognises loss allowances for ECLs on:

- financial assets measured at amortised cost; and
- contract assets.

The Company measures loss allowances at an amount equal to lifetime ECLs, except for bank balances for which credit risk (i.e risk of default occuring over the expected life of the financial instrument) has not increased significantly since initial recognition, which are measured at 12 month ECL.

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECLs. When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Company considers reasonable and supportable information that is relevant and available without undue cost or effort. This include both quantitative and qualitative information and analysis, based on the Company's historical experience and informed credit assessment and including forward-looking information.

The Company assumes the credit risk on a financial asset has increased significantly if it is more than 30 days past due. The Company considers a financial asset to be in default when:

 the debtor is unlikely to pay its credit obligations to the Company in full, without recourse by the Company to actions such as realising security (if any is held); or

- the financial asset is more than 120 days past due.

Lifetime ECLs are the ECLs that result from all possible default events over the expected life of a financial instrument.

12-month ECLs are the portion of ECLs that result from default events that are possible within the 12 months after the reporting date (or for a shorter period if the expected life of the instrument is less than 12 months).

The maximum period considered when estimating ECLs is the maximum contractual period over which the Company is exposed to credit risk.

Measurement of ECLs

ECLs are a probability -weighted estimate of credit losses. Credit losses are measured as the present value of all cash shortfalls (i.e. the difference between the cash flows due to the entity in accordance with the contract and the cash flows that the Company expects to receive).

ECLs are discounted at the effective interest rate of the financial asset.

Credit-impaired financial assets

At each reporting date, the Company assesses whether financial assets carried at amortised cost are creditimpaired. A financial asset is "credit impaired" when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occured.

Evidence that a financial asset is credit-impaired includes the following observable data:

- significant financial difficulty of the borrower;
- breach of contract such as a default or being more than 360 days past due;
- it is probable that the borrower will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

Presentation of allowance for ECL in the statement of financial position

Loss allowances for financial assets measured at amortised cost are deducted from the carrying amount of the assets.

Write-off

The gross carrying amount of a financial asset is written off when the Company has no reasonable expectations of recovering a financial asset in its entirety or a portion thereof.

For customers, the Company makes an assessment with respect to the timing and amount of write-off based on whether there is a reasonable expectation of recovery. The Company expects no significant recovery from the amount written off. However, financial assets that are written off could still be subject to enforcement activities in order to comply with the Company's procedures for recovery of amounts due.

ii Non-financial assets

At each reporting date, the Company reviews the carrying amounts of its non-financial assets (other than inventories, contract assets and deferred tax assets) to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated.

For impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or CGUs. The recoverable amount of an asset or CGU is the greater of its value in use and its fair value less costs to sell. Value in use is based on the estimated future cash flows, discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or CGU. An impairment loss is recognised if the carrying amount of an asset or CGU exceeds its recoverable amount.

Impairment losses are recognised in profit or loss. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

S Fair value measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date in the principal or, in its absence, the most advantageous market to which the Company has access at that date. The fair value of a liability reflects its non-performance risk.

A number of the Company's accounting policies and disclosures require the measurement of fair values, for both financial and non-financial assets and liabilities.

When one is available, the Company measures the fair value of an instrument using the quoted price in an active market for that instrument. A market is regarded as 'active' if transactions for the asset or liability take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

If there is no quoted price in an active market, then the Company uses valuation techniques that maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The chosen valuation techniques incorporates all of the factors that market participants would take into account in pricing a transaction.

If an asset or a liability measured at fair value has a bid price and an ask price, then the Company measures assets and long positions at a bid price and liabilities and short positions at an ask price. The best evidence of the fair value of a financial instrument on initial recognition is normally the transaction price – i.e. the fair value of the consideration given or received. If the Company determines that the fair value on initial recognition differs from the transaction price and the fair value is evidenced neither by a quoted price in an active market for an identical asset or liability nor based on a valuation technique for which any unobservable inputs are judged to be insignificant in relation to the measurement, then the financial instrument is initially measured at fair value, adjusted to defer the difference between the fair value on initial recognition and the transaction price. Subsequently, that difference is recognised in profit or loss on an appropriate basis over the life of the instrument but no later than when the valuation is wholly supported by observable market data or the transaction is closed out.

i Measurement of fair values

Some of the Company's accounting policies and disclosures require the measurement of fair values, for both financial and non-financial assets and liabilities. The Company has an established control framework with respect to the measurement of fair values. The Chief Finance Officer (CFO) has overall responsibility for overseeing all significant fair value measurements, including Level 3 fair values, and reports directly to the Audit Committee and Board of Directors.

The CFO regularly reviews significant unobservable inputs and valuation adjustments. If third party information, such as broker quotes or pricing services, is used to measure fair values, then the CFO assesses the evidence obtained from the third parties to support the conclusion that such valuations meet the requirements of IFRS, including the level in the fair value hierarchy in which such valuations should be classified. Significant valuation

issues are reported to the Audit Committee and Board of Directors. When measuring the fair value of an asset or a liability, the Company uses market observable data as far as possible. Fair values are categorized into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows:

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).

If the inputs used to measure the fair value of an asset or a liability might be categorized in different levels of the fair value hierarchy, then the fair value measurement is categorized in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement. The Company recognizes transfers between levels of the fair value hierarchy at the end of the reporting period during which the change has occurred.

6 Use of judgements and estimates

In determining and applying accounting policies, judgment is often required in respect of items where the choice of specific policy to be followed could materially affect the reported amounts of revenues, expenses, assets and liabilities of the company should it later be determined that a different choice would be more appropriate.

In addition, in preparing the accounts in conformity with IFRS, the company is required to make estimates and assumptions that impact on the reported amounts of revenues, expenses, assets, and liabilities of the company. Actual results may differ from these estimates.

These are discussed in more details below. These critical accounting judgments and key sources of estimation uncertainty should be read in conjunction with the full statement of accounting policies at Note 5.

A Judgements

Information about judgements made in applying accounting policies that have the most significant effects on the amounts recognised in the financial statements is as follows:

- Revenue Collectability of amounts receivable: Revenue may only be recognised if it is believed at the time of sale that the revenue is likely to be recovered from the customer. This recoverability requirement is not considered to have been met in contracts with customers who have a poor payment history and for which the Company believes the ability to manage the related credit risk on such contracts is impaired as a result. The Company does not recognise revenue on billings made on such contracts. Where the recoverability requirement is met, revenue is recognised on an accrual basis. The risk of non-collection is reflected as an adjustment to the revenue recognised as against recognising an impairment expense using the expected credit loss (ECL) method.
- Estimation of bills to unmetered customers: Bills to unmetered customers are estimated per feeder. The energy consumed by metered customers (postpaid and prepaid) on a feeder represents the accounted quantum of energy, while the difference between the total energy supplied to the feeder less technical losses and the accounted energy represents the unaccounted energy which is billed to unmetered customers in the proportion of their load wattage. The load wattage represents the estimated monthly minimum consumption of an unmetered customer. This is then used to multiply the grid factor which is the proportion of the unaccounted energy distributed to the feeder to the cumulative load wattage of all unmetered customers on the feeder.

Gross Current Replacement Cost refers to the total cost as at the date of valuation, of constructing an equivalent facility of equal utility to the existing one. This involves establishing the current cost of acquiring the assets together with ancillary costs of transportation and installation (e.g. material, labour including accommodation cum profit and attendance) including freight, insurance custom duty (IDR) and clearing where imported.

In 2016, the Nigerian Electricity Supply Industry ("NESI"), the Central Bank of Nigeria ("CBN"), the Federal Ministry of Petroleum Resources, the Federal Ministry of Power and the Nigerian Electricity Regulatory Commission ("NERC"), activated the Central Bank Nigeria-Nigerian Electricity Market Stabilization Facility 1 ("CBN-NEMSF 1") contract under the Disco Disbursement Agreement. The stabilization fund was partly to resolve the sector "NESI" liquidity issues. As such, intervention was determined for all market participants based on MYTO.

The Central Bank Nigeria - Nigerian Electricity Market Stabilization Facility ("CBN-NEMSF") is secured on the Company's collections from the sale of energy as first line charges. Interest rate charged on the facility is at 9% per annum.

The first drawdown of NGN 289 million on the loan was in 2018 and an additional NGN 6.5 billion was disbursed under the facility in 2022.

The stabilization fund was partly to resolve the sector "NESI" liquidity issues. As such, intervention was determined for all market participants based on MYTO.

The Central Bank Nigeria - Nigerian Electricity Market Stabilization Facility 2 ("CBN-NEMSF 2") is secured on the Company's collections from the sale of energy as first line charges. Interest rate charged on the facility is at 9% per annum. During 2023, the first drawdown of NGN 1.09 billion was disbursed to the Company under the facility.

(c) CBN-NMMP

The CBN-NNMP loan is the mass metering programme that involves the supply of Prepaid meters to the customers at no cost to them. The programme is to replace the previous Meter Asset Procurement (MAP) program where customers pay for their meters.

Under this arrangement, disbursement for procurement of the meters is made directly to the meter vendors by the CBN on behalf of the Company with a first line charge on the Company's cash collections as security

for repayment. The first disbursement of NGN 3.1 billion was done in December 2022 with an interest rate of 9% per annum.

(d) QENL Loan

On 30 December 2021, the Company obtained and drew down an unsecured facility of NGN 2.48 billion from Quest Electricity Nigeria Limited (QENL), its parent company, to meet certain obligations of the Company to labour unions and employees disengaged as part of the restructuring exercise prior to the take over of the Company by QENL. The facility is a 1-year and 4 months facility with an interest rate of NIBOR + 4% and a moratorium of 365 days on interest repayment from the date of first disbursement. The loan matured on 30 April 2023 and was repayable in full, principal plus any unpaid accrued interest.

On 01 May 2023, the loan was restructured to extend the maturity date to 01 March 2033, revise the principal to include the intercompany payable of NGN 2.85 billion to QENL as at 30 April 2023, amend the contractual interest rate from NIBOR + 4% to 5%, waive the penalty chargeable in event of default, make an additional NGN 200 million available for drawdown and grant moratorium of 1 and 5 years on interest and principal repayments respectively. The Company drew down on the additional NGN 200 million on 04 November 2023.

The amendment resulted in the recognition of NGN 2.78 billion as capital contribution being day-one gain arising from recognizing the new loan at fair value (2022: NGN Nil). See Note 23(a).

(e) Spillgate Loan

The Company has two facilities with SpillGate Investment Limited (SPIL):

- The first facility is a short-term facility of NGN 1 billion and was obtained on 30 July 2022 to finance capital expenditure. The facility is a 1-year facility with a 20% premium and repayable in monthly instalments of NGN 100 million over the tenor. The loan is secured through an irrevocable standing order on one of the Company's bank accounts in a commercial bank and in the event that the Company fails to repay the loan amount and accrued interest at the expiration date, SPIL shall be at liberty to call in the standing order and retain the proceeds therefrom up to the value of the loan amount, in satisfaction of same. During 2023, the Company defaulted on repayments. However, SPIL did not demand for full repayment nor call in the standing order. On 17 August 2023, the terms of the loan was renegotiated between SPIL and the Company to extend the maturity date to 30 July 2024, make an additional NGN 200 million available for drawdown and to grant a moratorium of 5 months on principal repayments, including the outstanding principal prior to renegotiation. The Company drew down on the additional NGN 200 million on 21 August 2023.
- The second facility is a short-term facility of NGN 650 million and was obtained on 31 October 2023 to finance working capital needs. The facility is a 1-year facility with a 20% premium and repayable in monthly instalments of NGN 65 million over the tenor. The loan is secured through an irrevocable standing order on one of the Company's bank accounts in a commercial bank and in the event that the Company fails to repay the loan amount and accrued interest at the expiration date, SPIL shall be at liberty to call in the standing order and retain the proceeds therefrom up to the value of the loan amount, in satisfaction of same.

(f) Commercial bank loans

During 2023, the Company obtained two short-term facilities from a commercial bank to finance advance payments to its vendors. The first facility is a NGN 1.46 billion, 12-month facility with a 14% interest rate per annum with an upfront management fee of 0.5%. The second facility is a NGN 2.18 billion, 12-month facility with a 20% interest rate per annum with an upfront management fee of 0.75%. The interest rates are subject to review in line with prevailing market conditions. The loans are secured through a lien on Mainstream Energy Solutions Limited's bank accounts with the commercial bank. Total transaction costs incurred on these facilities amounted to NGN 25.44 million.

(a) Legal

The provision for legal relates to litigations and claims the Company is involved in at year end. Provision for legal takes into consideration an independent assessment performed by the Company's legal solicitors engaged to represent the Company on those cases. 28 Contingent liabilities

(a) Transfer of pre-handover liabilities and trade receivables

As part of the privatisation initiative and the restructuring of the Nigerian power sector, NELMCO was established to take over and manage the stranded assets and liabilities in the Power sector. As as result, all trade receivables and the liabilities of the Company as at 01 January 2022 were derecognized and transferred to NELMCO under relevant Pre-Handover Liabilities and Receivables Transfer Agreement. Although the Company and NELMCO are yet to agree on the individual trade debtors and liabilities transferred, the directors, based on independent legal advice obtained as well as their understanding of the Share Purchase Agreement between QENL, BPE and the Ministry of Finance Incorporated are of the opinion that all liabilities (crystallised or contingent) as at 01 January 2022 have been effectively transferred. As such, the Company will neither realise those receivables in its own capacity or settle any liabilities incurred on or before 01 January 2022.

On this basis, a net debit of NGN 691 million which represents the net assets transferred has been recorded in equity as it represents a shareholder contribution to the Company (Note 11). Any difference between the amounts transferred per these financial statements and those to be agreed to by NELMCO may result in an increase or decrease to the net amount recorded in equity.

(b) Pending litigation and claims

There are certain lawsuits pending against the Company in various courts of law. The total contingent liabilities in respect of pending litigations as at 31-Dec-2023 is NGN 16.77 million (31-Dec-2022: 25.50 million). Based on

independent legal advice, the directors are of the opinion that no material loss is expected to arise from these claims and as such, no provision has been recorded with respect to these claims.

29 Related parties disclosures

(a) Parent and ultimate controlling party

Effective 1 January 2022, a majority of the Company's shares was acquired by Quest Electricity Nigeria Limited from Bureau of Public Enterprises - BPE and Ministry of Finance Incorporated - MOFI. Consequently, the Company's parent is Quest Electricity Nigeria Limited. The ultimate controlling party of the Company is Mainstream Energy Solutions Limited, a company incorporated in Nigeria.

(b) Related party relationships and transactions

The Company entered into the following transactions with the under-listed related parties during the year:

i Mainstream Energy Solutions Limited

Mainstream Energy Solutions Limited (MESL), a company incorporated in Nigeria, operates in the power sector and its principal activity is to own and operate power plants for the generation of electric power in Nigeria. MESL is the ultimate parent company of the Company following the acquistion of a majority stake of 60% in the equity of the Company by Quest Electricity Nigeria Limited, a wholly owned subsidiary of MESL. During the year, MESL provided foreign currencies to the Company to settle its foreign currency denominated liabilities. Total funds provided was USD 1.6 million (2022: USD 668 thousands). The Company repaid NGN 1.19 billion (2022: NGN 300 million) during the year and amount due to MESL as at year end is NGN 78 million (2022: NGN 134 million).

In addition, MESL backed a payment guarantee facility of NGN 1.055 billion issued by a Nigerian bank on behalf of the Company in favor of the Nigerian Bulk Electricity Trading Plc (NBET). This is intended to guarantee payment on minimum remittance obligations on market invoices from NBET and secured by a lien on 100% cash collateral on MESL's account with the bank. The tenor of the guarantee is one year, with a maturity date of September 2024.

ii Quest Electricity Nigeria Limited

On 1 January 2022, Quest Electricity Nigeria Limited (QENL) gained control of the Company following the acquistion of a majority stake of 60% in the equity of the Company. On 30 December 2021, QENL provided a loan facility of NGN 2.48 billion to the Company to meet certain obligations of the Company to labour unions and employees disengaged as part of the restructuring exercise prior to the take over of the Company by QENL (Note 25(d)).

On 01 May 2023, the loan was restructured to extend the maturity date to 01 March 2033, revise the principal to include the intercompany payable of NGN 2.85 billion for items and services paid by QENL on behalf of the Company as at 30 April 2023 amongst other revisions to the original terms of the loan. See Note 25(d) for more details.

iii Societe Nigerienne D'Electricite

In 2022, the Company entered into a Technical Services agreement with Societe Nigerienne D'Electricite (NIGELEC), an utility company incorporated in Republic of Niger for the provision of local, top level and expatriate staff to enable the Company meet the performance standards in the Performance Agreement. Such technical services includes those geared towards the reduction of Aggregate Technical, Commercial and Collection Losses, revenue cycle management, e.t.c.

Total costs incurred by the Company with respect to the services provided for the year was NGN 1.90 billion (USD 2.82 million). Amount due to NIGELEC as at year end is NGN 2.20 billion (USD 2.31 million) (2022: 229.99 million (USD 512 thousands)).

iv Spillgate Trading and Investment Limited

Spillgate Trading and Investment Limited (SPIL), a company incorporated in Nigeria, is a special purpose entity established to acquire and hold for investment purposes and maintain shares, stock, debenture stock, bonds, promissory notes and several other investment type. It is a wholly owned subsidiary of MESL.

Risk management framework

The Company's Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework.

The Company's risk management policies are established to identify and analyse the risks faced by the Company, to set appropriate risk limits and controls, and to monitor risks and adherence to limits. Risk management policies and systems are reviewed regularly to reflect changes in market conditions and the Company's activities. The Company, through its training and management standards and procedures, aims to maintain a disciplined and constructive control environment in which all employees understand their roles and obligations.

The Company's board of directors oversees how management monitors compliance with the Company's risk management policies and procedures, and reviews the adequacy of the risk management framework in relation to the risks faced by the Company.

(a) Credit risk

The Company is exposed to both settlement risk defined as the risk of a counterparty failing to pay for energy and/or services which have been delivered. Credit risk is mitigated by active engagement and reconciliation of energy supplied to the customers and promotion of compliance with the MYTO agreement. Credit risk is an activity managed by the Directors with all relevant stakeholders to ensure reduced impact on provisioning policy. The allowance for doubtful debts is analysed at each reporting date and this is estimated by management taking into account future cash flows, prior experience, ageing analysis and an assessment of the current economic climate within which the company operates. The maximum exposure to credit risk in respect of trade receivables is the carrying value of the trade receivables at the reporting date. The carrying value of trade receivables is stated net of the allowance for recoverability provision.

The credit risk on liquid funds and non-derivative financial instruments is limited because the counterparties are banks with high credit-ratings assigned by international credit rating agencies and related companies.

(i) Trade receivables

The Company's exposure to risk is influenced mainly by the individual characteristics of each customer. However, management also considers the factors that may influence the credit risk of its customer base, including the default risk associated with the industry in which customers operate.

The Company has a large customer base within its licensed area of supply thereby reducing its concentration of credit risk. To further mitigate credit risk, the Company is continually increasing the share of prepaid customers in its portfolio. (ii) Receivables from NBET

The Company has receivables due from the Nigerian Bulk Electricity Trading Plc in respect of excess payments made on minimum remittance obligations during the year. The Company has not recognized an impairment allowance on this receivable as the Company buys electricity from NBET and expects to offset this amount against future amounts owed to NBET and expects to offset this amount against future amounts owed to NBET.

(iii) Other receivables

The Company has receivables due from the Nigerian Electricity Liability Management Company (NELMCO) in respect of payments made on debts to NBET and MO for November and December 2021. The Company has not recognized an impairment allowance on this receivable as the Company has a liability of NGN 1.69 billion to NELMCO as cash collections received from customers in respect of the legacy debts which had been transferred to NELMCO in line with the deed of assignment of precompletion receivables as well as cash balances at 31 December 2021.

(iv) Feeder Accounts balance

The Company has bank balances amounting to NGN 799.59 million at 31 December 2023 (2022: 878.86 million) in its Feeder Collections accounts with restrictions on the use of these balances as part of the requirement for the CBN - NEMSF and CBN - NMMP facilities. These balances can only be transferred into the Company's Principal Collection Account and cannot be used for no other purpose. The Company has not recognized an impairment allowance on these balances as the cash reside with banks that have good credit ratings ranging from AAA to BBB- rating based on Fitch, and Agusto & Co.

(v) Meter Acquisition Fund balance

The Company has cash amounting to NGN 147.49 million at 31 December 2023 (2022: Nil) sequestered in its Principal Collection Account which was restricted for use as it represented the Company's contribution to the Meter Acquisition Fund initiative by NERC. The Company has not recognized an impairment allowance on this balance as the cash reside with a bank that has a good credit rating of B based on Fitch.

(vi) Cash at bank

The Company held cash and cash equivalents of NGN 1.57 billion at 31 December 2023 (2022:NGN 4.10 billion). The cash and cash equivalents are held with bank and reputable financial institutions in Nigeria.

Impairment on cash and cash equivalents has been measured on a 12-month expected loss basis and reflects the short maturities of the exposures. The Company considers that its cash and cash equivalents have low credit risk based on the external credit ratings of the counterparties.

(b) Liquidity risk

Liquidity risk is the risk associated with its financial liabilities that are settled by delivering cash or another financial asset. The Company's approach to managing liquidity is to ensure, as far as possible, that it will have sufficient liquidity to meet its liabilities when they are due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Company's reputation. Ultimate responsibility for liquidity risk management rests with the Board of Directors, who has built a liquidity risk management framework for the management of the Company's short, medium and long-term funding and liquidity management requirements. The Company maintains adequate liquid reserves, by monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

The Company closely monitors and manages its liquidity risk. Cash forecasts are regularly produced and sensitivity run for different scenarios including, but not limited to, changes in Energy Tariff and changes in distribution class and status of customers. The Company also continues to intensify efforts to collect its trade receivables.

(c) Market risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, interest rates and equity prices will affect the Company's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimizing the return. The Company manages market risks by keeping costs low through various cost optimization programs. Moreover, market developments are monitored and discussed regularly, and mitigating actions are taken where necessary.

Currency risk

The Company is exposed to currency risk on cash and cash equivalents held and payment of expatriates within the Company's employ. These transactions are denominated in a currency other than its functional currency, the Naira. The currency in which these transactions are primarily denominated is the US Dollar (USD). The currency risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate due to the changes in foreign exchange rates.

In managing currency risk, the Company aims to reduce the impact of short-term fluctuations on foreign transactions. The Company has no export sales, thus the exposure to currency risk in that regard is non-existent.

Although the Company has various measures to mitigate exposure to foreign exchange rate movement, over the longer term, however, permanent changes in exchange rates would have an impact on profit. The Company monitors the movement in the currency rates on an ongoing basis.

(C) Capital Management

33 Events after the reporting date

(a) Revocation of Power of Attorney granted by MoFI to BPE

On 15 January 2024, the Ministry of Finance Incorporated (MOFI) formally terminated the Power of Attorney (PoA) granted to the Bureau of Public Enterprises (BPE) in the 11 Electricity Distribution Companies (Discos), directing that henceforth, equity interests of the Federal Government of Nigeria (FGN) in all electricity successor companies be restored, and held and treated by MoFI. As at the date of the issuance of these financial statements, this change has not been effected.

(b) Migration of Band-A customers to Cost-Reflective Tariffs

The regulator, NERC, via the April 2024 Supplementary Order for the Company, approved that customers on Band A pay a cost-reflective tariff effective 03 April 2024. This move is to ensure that the customers enjoying a minimum daily average of 20hours power availability pay for such. The said tariff is being adjusted on a monthly basis to reflect both the current macro and micro economic indices in the economy and especially as they affect the power sector.

(c) Order on Operationalisation of "Tranche A" of Meter Acquisition Fund

On 19 June 2024, the regulator, NERC, issued an order that provided a transparent and functional framework for the operationalisation of the first tranche of metering under MAF scheme, eligibility conditions for access to first tranche of funding under MAF, and the terms of payment, monitoring and evaluation and other conditions for manufacturers and Meter Asset Providers (MAPs) participating under the scheme. NERC approved the utilisation of NGN 243 million under Tranche A of the scheme by the Company to procure and install meters for unmetered Band "A" customers within its franchise areas.

(d) Order on the Transition to Bilateral Trading in the Nigerian Electricity Supply Industry ("NESI")

On 25 July 2024, NERC issued an order to allow for direct contractual agreements between electricity generators (GenCos) and distributors (DisCos), bypassing the traditional market structure dominated by the Nigerian Bulk Electricity Trading (NBET) company. This move is intended to promote competition, improve efficiency, and attract private investment in the sector. The order is part of broader efforts to reform the NESI, ensuring a more reliable and sustainable electricity supply across Nigeria.
